## The Administration report was presented to Council including:

- Of the 10 utility customers all have made arrangements.
- We are currently without a public works operator as one is on holiday, one injured. Garbage and snow will be completed by casual contract and water wastewater by County staff. The injured staff member has the emergency cell phone in case a call is received and he will contact administration.
- The Tax Auction sale was conducted on January 17, 2018. One bidder attended, one property sold. This is a business item on the agenda
- All administrators met January 24, 2018 and discussed the regional Federal multi-culturalism grant application originally begun February 2017. This a business item on the agenda.
- Munisightes (GIS) is up and running and more information is accessible on the site. The public site is accessible also, also. Councillor training sessions were offered at the County office on effective use of the site for information.
- The auditors will be in the Village office February 21st, 2018. Much work has already been done.
- Year-end invoicing to the Library, County and Aspen View Schools were sent and we received payment from the County and Aspen View.
- Lift Station We have now received the generator, and await only the pumps, control panel and other accessories (heater, plug valves, etc.) which are finally in transit from Sweden. One item integral to pump installation is backordered to March 5<sup>th</sup>. The contractor has been advised to get ready to start the project.
- The bottle depot should have re-opened today.

- Bonnie Lake Campground We have been approached about booking the entire campground for a family reunion/celebration of life for the July long weekend also. It is booked for now and await final site numbers required. We have already booked (6 sites) for the May long weekend.
- We have applied for an Alberta Community Partnerships Local Land Use Planning grant offered by the Alberta Government. This is a business item on the agenda.
- RCDC is requesting approval of each respective council for the Mandate Letter and the 2018 budget these are business items on the agenda.
- It seems that we can no longer rely on good sense and provincial/federal traffic laws to control issues with the same on Village streets. A traffic bylaw was drafted in 2012 and is now being re-introduced to Council for review. Your input is requested keeping in mind that the bylaw will have to be enforced with the resources we currently have OR with a significant cost to the ratepayer for a bylaw officer.
- It is time to review the Joint Fire Services Agreement with Smoky Lake County. If there are any matters within the current one that you wish to address, our two Councils will meet to discuss it. This item is on the agenda in business.
- I will be away March 12-16 for the water conference and April 10-13 for Critical Incident Crisis Intervention Training at Lakeland College Vermillion. The office will be covered on the necessary days.
