

BYLAW NO. 530-17

**A BYLAW OF THE VILLAGE OF VILNA
IN THE PROVINCE OF ALBERTA
TO AMEND THE LAND USE BYLAW, BYLAW NO. 392-98**

WHEREAS the Municipal Government Act, R.S.A. 2000, as amended ("the Act") authorizes the Council to establish and amend a Land Use Bylaw;

NOW THEREFORE, the Council of the Village of Vilna, duly assembled, enacts as follows:

- 1. The Land Use Bylaw of the Village of Vilna, Bylaw No. 392-98, is hereby amended as follows:

Change the classification of those portions of land legally described as follows:

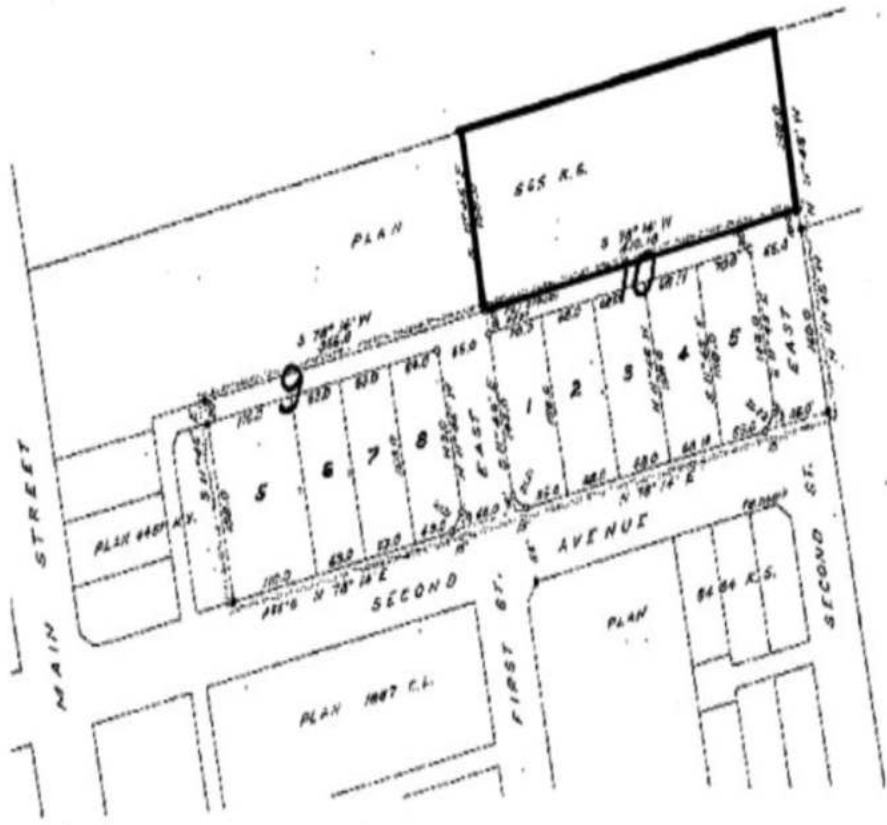
