### **Evergreen Regional Waste Commission**

#### **Doctor Recruitment and Retention Committee**

Dr. Raubenheimer Clinic has returned \$85,000.00 of the funds that had been set up to assist a new doctor to emigrate to Canada and to the Smoky Lake Region.

They further agreed to provide funds in the amount of \$5,000.00 to assist Dr. Laurnenz in his Immigration Process.

The Vilna Health Centre is in need of roof repairs, but it seems the Alberta Health maintenance Board seem to be hesitant to provide the funds.

The doctors attending the clinic in Vilna have reduced their hours to coincide with the lab schedule which has resulted in a wait time of weeks for appointments.

# **PUBLIC WORKS**

• On September 16<sup>th</sup> the garbage truck turned a corner too sharply in the alley behind the shop. It hit the power pole and took out much of the telephone services in the area. No one was hurt. Repairs have been ongoing.

- Hopefully it won't be much longer. This will be an insurance claim. I have notified the insurers.
- The 4-way Stop Signs will be installed at 50<sup>th</sup> st. and 50<sup>th</sup> ave this week. I miscalculated the order and I need to order 1 more sign for the 52<sup>nd</sup> avenue intersection.
- Public Works has been checking fire hydrants. We still have a couple that need repairs.

#### **BONNIE LAKE**

- Matt Reported that the bookings are coming in. So far we have realized approximately \$17,000.00 in fees and expenses are about \$17,600.00. Best year ever.
- The campground is scheduled to shut down at the end of September.

# Paving - 49 Ave

• I understand they will be back to touch up some small repairs.

### **Water Meter Replacements**

• The meters have been ordered. It could be 6 weeks before they get here. It seems there's a shortage in western Canada.

#### **Water Reservoir**

- Alberta Environment will be inspecting the Water Plant this week. I hope the inspection was triggered by my request for funds to replace the reservoir.
- The inspection has indicated that the reservoir is deteriorating rapidly and should be replaced immediately.
  - Lisa Van Popta has indicated that the concrete is deteriorating under the tennis court area and has agreed to help to speed up the process for financial assistance.

#### **CENTENIAL PARK**

• Land Titles is about 2 months behind in getting titles transferred. So far we don't have title to the park yet.

#### **2021 ELECTIONS**

• On Nomination Day we received 3 nominations for Council. Leroy Kunyk, Tammy-Lynn Thompson and Paul Miranda. They have been acclaimed so we will not have to have a municipal election. We will still have to hold the election for the Provincial Referendum and the Senate election. Because we won't be holding a municipal election they will be paying us \$4,000.00 instead of the \$2,000.00 previously noted. We will still have to have the Advance Polls.

### **GRANT APPLICATIONS**

- The regional Administrators interviewed the candidates who submitted proposals for the Regional Service Study. They have recommended that the Village enter into an agreement with 13-Ways Inc.
- An application is being prepared to have a study done on the High Speed Internet in the region.

### **ARBORETUM**

• The owner of the property located at the SE corner of 49<sup>th</sup> Avenue and 52<sup>nd</sup> Street in 1919 was Norman Wright. It is assumed that it would be his family that is buried on the property.

# LAND GRANT FROM THE ESTATE OF FRANK PAWLOWSKI

• The papers have been signed by Mr. Pawlowski's executor and are being mailed to us for processing.

Managing Partner, Town of Smoky Lake to distribute the said funds when received.
