#### UTILITIES

• At the end of November we had 100 new remote read meters installed. Now we're waiting for the technology to catch up. We have a hand held reader but I didn't realize we had to have the software installed on the office computers in order to be able to download the readings. I dragged my heals a little. Thought I would just manually enter the readings and save money on the software. Oops.

We should have the readings in the next day or 2 and I can complete the billings.

#### **PUBLIC WORKS**

- I agreed with Public Works that using the equipment when it was minus 30 or minus 40 just was not a good idea. They kept the main roads clear and the alleys for garbage collection.
- With the severe weather they left a good snow pack so the water lines would be insulated.
- We will have to hire a truck to haul the snow piles away before too long.

## **Water Meter Replacements**

• We still have about 50 properties to be fitted with the new meter. We didn't replace any of the larger meters yet. They are waiting. Many of the regular sized ones are in crawl spaces so we've decided to wait until spring to complete the project.

#### **Water Reservoir**

- Just received a memo from Alberta Environment indicating that the tests all indicate that the water is stable and there does not appear to be any sign of infiltration.
- The grant application was sent to Alberta Transportation but the grant deadline was moved to February 28<sup>th</sup> with the awarding probably not until March or April. And so, we wait.

## **CENTENIAL PARK**

• I'm preparing a grant application for federal money under "Celebration and Commemoration Program". I need someone who is far more creative than I am to design the park.

# **GRANT PROJECTS**

• The Regional Services Study project is well underway. Each of the municipalities have had an opportunity to meet with the consultants. I believe the next stage will be in late January.
