# e) Shane Griggs & Roberta Dimitriou

The property access has never been developed, and therefore has not been marketed since the cost of building access is more costly than the property is worth. ### **Evergreen Waste Commission - April 21st.**

• Banff has a biodigester that heats all municipal buildings. Soil conservation is becoming a critical issue. Traditionally, 1 cubic meter would have an average of 40 earthworms. Recent studies are only finding an average of 2 earthworms. Too many chemicals in the world are being blamed. Scavenging is an increasing issue, including Smoky Lake and Spedden, with individuals acting aggressively and harassing

staff. Scavenging is technically theft, so RCMP to be contacted. Excellent board orientation session with Brownlee Law.

## Centennial - April 27th.

 Discussion of advertising with Go East. No winners of logo contest announced. No posters or advertising yet beyond Ag. Society website. Committee brainstorms to create an alternate logo to begin sourcing quotes for merchandise. Several food trucks have already committed. School tour looks viable. Town cleanup would be appreciated. Uncertainty of how to build or decorate a parade float for the village.

### UTILITIES

• We have hired Bruce Smith to install more of the remote meters. He still has 17 residential meters to install. The rest have larger meters such as the fire hall, the schools, etc.

• Because it's difficult to get grants it has been suggested that the park be developed in stages, beginning with clearing the treed area and preparing the paths, followed by planting deciduous trees and greens.

• I don't want to deal with a Tax Recovery Auction Sale in August, it can either be held in July or September.

# CENSUS

- The 2021 Federal Census showed our population has gone down from 290 to 268, a drop of 7.5%. I did a conservative straw poll and counted 261 plus the Lodge population of about 24 for an estimated population of 285.
- What I did find is that the population dynamics has changed a little. The greatest change is the percentage of employment age (15-65) 50%. We now have a population of children 16.5% and our senior population is 33.5%.
- Most of our grant funding is based on our population. I thought it might be beneficial to do a municipal census in order to increase our grants. However, the province has indicated that they will no longer accept municipal census to determine grant funding, so doing a census probably won't be beneficial.

# BYLAW CONCERNS

- It's spring and every dog in town thinks the streets are a free playground. I've had to address a couple dog concerns, especially with unfriendly dogs.
- I've send out letters to everyone that I think owns a dog, asking them to get a license.

- The bins behind the Village Office are well used. I can tell who has read their newsletter and who hasn't. The ones that haven't read it come in and ask if the bins are for anyone to use. The others just use them.
- I will be sending out letters to the residents who need a little nudge to clean up their yards.

#### WATER RESERVOIR

- No word on the grant yet.
- A letter from an Alberta Environment Engineer is attached to this report. In summary, so far the reservoir is still okay.

"April 28, 2022

"Good morning everyone:

I received and reviewed the treated water quality between HWY 28/63 and Vilna' treated water reservoirs to confirm no-leakage at reservoirs (compromising the stored water quality), due to deterioration of reservoirs' physical conditions. Vilna has been requested to perform this task every months and report to AEP and AHS for review, comments and necessary follow up actions.

Latest reports of water quality on Apr 28, 2022 depicts that (comparing between HWY 28/63 vs. Vilna' res. stored water):

• BTEX – no significant deviations noted (identical results) i.e., no hydrocarbon contamination

• Total chlorine – Vilna res. is maintaining at 1.1 mg/L (HWY @ 1.3 mg/L) 2 previously observed accelerated chlorine residual loss within res. is slower than before, considered cond. Is improving

• Conductivity, Chloride, Sulphate, E-coli, T-Coliform – comparable results between two samples

• Turbidity – res. water is at 0.38 NTU compared to HWY line is at 1.2 NTU (stored water has better results than turbulent regional line water)

T Sodium – identical between them.

So, in summary: the reservoirs' probability of leakage has not been evident, compromising the stored water quality. HOWEVER, visual inspections of reservoirs' condition is deteriorating (reported by Vilna' engineering consultant), so that replacing or upgrading reservoirs will be an ultimate solution for Vilna' long term drinking water strategy, and AEP has been supporting this solution within its capacity.
