- It doesn't look like any of the incumbent Council are going to run in the election this year.

## 2021 MUNICIPAL ELECTION October 18, 2021 Vote at the Village Office 5135 – 50 Street 10:00 a.m. to 8:00 p.m.

- Nominations are open until noon of September 20<sup>th</sup>, 2021.
- **To be eligible to run in the Municipal Election** you are required to fulfill 6 criteria.
  - You must be 18 years of age,
  - You must be a Canadian citizen,
  - You must have lived in the Village for 6 months prior to the election;

- You can't be in default on a debt owed to the Village for an amount over \$500.00,
- Can't owe more than \$50.00 in taxes,
- In the past 10 years you have not been convicted of an offence under the Local Authorities Elections Act, the Provincial Elections Act nor the Canada Elections Act.
- To be eligible to vote there are far less conditions,
  - You have to be 18 years of age, a Canadian citizen and a resident of Vilna.

# PROVINCIAL REFERENDUM AND SENATE ELECTION

- At the Municipal Election on October 18<sup>th</sup>, at the Village Office, you will be given two Provincial Ballots,
- to select 3 Senate nominees who may be summoned to the Senate of Canada, to fill a vacancy or vacancies relating to Alberta.
- 2) Two Referendum Questions;
- Should section 36(2) of the Constitution Act, 1982 Parliament and the government of Canada's commitment to the principle of making equalization payments – be removed from the constitution?
- Do you want Alberta to adopt year-round Daylight Saving Time, which is summer hours, eliminating the need to change our clocks twice a year?

#### WATER METER REPLACEMENT PROGRAM

Within the next month you will be contacted by someone from NEPTUNE TECHNOLOGY GROUP. They are the company that will be replacing your water meter, so will be contacting you to set up a time for the work to be done.

They will be identifying themselves and you will receive confirmation from the Village.

The new meters will have a remote reader on them so you will no longer be asked to read your meters for us.

#### PET OWNER'S BYLAW

In June Council gave 3<sup>rd</sup> reading to a Bylaw that would allow you to raise up to 6 hens (not roosters) in the Village, or you can raise one hive of bees.

#### BEFORE YOU RUSH OUT AND BUY CHICKENS OR

**BEES,** the rest of the Bylaw requires that you apply for a permit. The permit will ask you to talk to your neighbours and ensure that they are in agreement with you having chickens or bees.

You also have to indicate that you have proper fencing and shelter for the chickens and indicate that you have met the site regulations.

Only property owners have the luxury of owning chickens or bees.

The Bylaw also regulates the ownership of dogs. All dogs in the Village must be licensed, detained on the owner's property or held on a leash in control of the owner when off the property.

Fees and Charges levied against violators will be charged against the property taxes if not paid within 30 days. So if you're a landlord, you're going to want to make sure your tenant is following the rules.

The enforcement of the Bylaw isn't going very well. Perhaps that's because I haven't advertised it enough, or perhaps it's because my Newsletters aren't being read.

If we can't get people to respect their neighbours and follow the regulations, Council might have to cancel these new options and increase your taxes to pay for a Bylaw Enforcement Officer.

- Have your garbage out before 8:30 a.m.

- There is a \$20.00 fee to remove the Freon from fridges and freezers.
- Only domestic waste is accepted at the Transfer Station. Construction waste and furniture must go to Spedden.
