Property owners must control noxious weeds and destroy prohibited noxious weeds on the land they occupy. Noxious weeds include:



EMS: If We Can't Find You, We Can't Help You "Make sure your house number is clear and visible. When an emergency happens, every second counts. You don't want critical seconds to be spent by emergency

responders trying to locate your house because you haven't properly displayed your address. Unmarked houses cause unnecessary delays.

If you haven't already done so, please make sure that your home number is clearly visible so that we can find you in the case of an emergency. " It's your responsibility to make sure your address is visible. If emergency services (police, fire, ambulance) have a hard time finding your home because the address is hard to see, it has to be changed. Numbers should be at least 3 inches high and clearly visible. You can purchase street numbers and sign kits at most hardware stores or online that are easy to affix. If you decide to make vour own sign, remember to use reflective numbers that are at least 3 inches high. Please be sure to trim any bushes away from your signs so that all numbers are clearly visible and not blocked by flowers, planters, flags, or other items.

And if you notice that your neighbor doesn't have a visible house number, lend them a hand. Let's all be neighbors helping neighbors

#### Noxious weeds

Under the <u>*Weed Control Act*</u> noxious weeds must be controlled.

Noxious weeds have the ability to spread rapidly, cause severe crop losses and economic hardship.

### **COMMUNITY STANDARDS BYLAW**

#### 1. Property Maintenance, Land & Buildings

- 1.1. For the purpose of this part, a Person who is the Owner or Occupier shall be considered to occupy the Boulevard and Sidewalks immediately adjacent to their Property.
- 1.2. A Person shall not cause or permit a nuisance or unsightly condition to exist on Property they own or occupy.
- 1.3. A Nuisance or Unsightly Condition in respect of Property means Property that shows serious disregard for general maintenance and upkeep, whether or not it is detrimental to the surrounding area, including but not limited to:

- 1.3.1. excessive accumulation of material including Building materials, appliances, household goods, boxes, tires and vehicle parts whether of apparent value or not;
- 1.3.2. loose litter, garbage, garden or lawn waste, refuse or animal feces, whether located in a storage area, collection area or elsewhere on the Property;
- 1.3.3. unkempt grass or Weeds;
- 1.3.4. any excavation, depression, drain or ditch, watercourse, pond, surface water or other matter or thing that may be dangerous to the public safety or health;
- 1.3.5. production of any generally offensive odor originating from the Property;
- 1.3.6. any tree, shrub, other type of vegetation or any structure that:
  - 1.3.6.1. interferes or could interfere with any public work or utility;
  - 1.3.6.2. obstructs any Sidewalk or Highway adjacent to the Property; or
  - 1.3.6.3. impairs visibility required for safe traffic flow at any intersection adjacent to the Property;
- 1.3.7. the failure to keep Property in a reasonable state of repair, which includes, but is not limited to:
  - 1.3.7.1. the significant deterioration of buildings, structures, fences or improvements, or portions of buildings, structures or improvements;
  - 1.3.7.2. broken or missing windows, doors, doorframes, siding, stairs, steps, hand railings, landings, balconies, patios, fences, shingles, shutters, eaves, or any other building material;
  - 1.3.7.3. significant fading, chipping, peeling, rotting or absence of paint on areas of buildings, structures, fences, or improvements on the Property; or
    - 1.3.7.4. conditions that may create a danger to public safety in the opinion of a Bylaw Enforcement Officer.

# **OFF HIGHWAY VEHICLES**

#### Village of Vilna Traffic Bylaw

- 14.1 No person shall operate an Off Highway Vehicle within the corporate limits of the Village unless:
  - 14.1.1 they are fourteen (14) years of age or older;
  - 14.1.2 they are traveling on the most direct route when going to and returning from their destination.
  - 14.1.3 it is between the hours of 8:00 a.m. and 10:00 p.m.; and
  - 14.1.4 the maximum rate of speed which a Driver may operate an Off Highway Vehicle within the Village shall be twenty (20) kilometers per hour.
  - 14.1.5 Regulations defined and outlined in the <u>Traffic Safety Act</u> and <u>Off</u> <u>Highway Vehicle Regulation are</u> <u>adhered to.</u>
  - 14.1.6 the Off Highway Vehicle has a vehicle registration.

#### And Alberta legislation requires:

- your OHV is registered and insured
- your OHV is equipped with a licence plate, head-light, tail-light, muffler and a spark arrester
- the driver of the OHV is at least 14 years of age unless the child is closely supervised by an adult of at least 18 years of age and is wearing a helmet.

• Helmets are required for anyone driving, operating, riding in or on, or being towed by, an OHV .

## How much is a ticket for not stopping at a stop sign in Alberta?

In Alberta, failing to stop at a stop sign can result

in **a \$405.00 fine and 3 demerits**. At a stop sign, drivers must come to a complete stop before proceeding safely through the intersection. This gives drivers the opportunity to look for oncoming traffic, pedestrians, or cyclists.
