

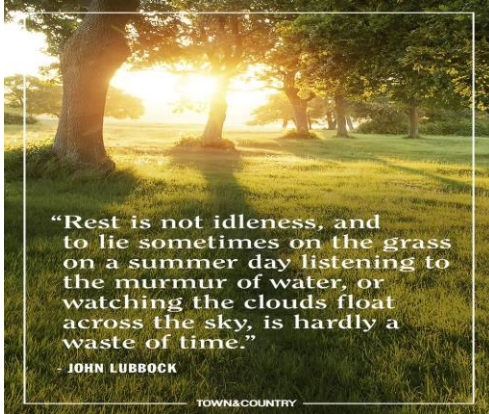

COMMUNITY STANDARDS BYLAW:

16 ADDRESSING

EVERY BUILDING NEEDS A VISIBLE ADDRESS

16.1 The owner of a Property on which a Building has been erected shall display the civic address number assigned to the Property at a location plainly visible (5 inches) from the roadway in front of the property.

***We require the 4 digit house number. (i.e. 5035)
The street or avenue numbers are optional.***

- ***Penalty for non-compliance - \$50.00***

If not installed the Village will hire a contractor to provide and install the numbers and the costs will be attached to the property taxes.

5. PROPERTY MAINTENANCE

5.2 A person shall not cause or permit a nuisance or unsightly condition to exist on property they own or occupy.

5.3.1 Excessive accumulation of materials

5.3.2 Loose litter, garbage, garden or lawn waste, animal feces.

5.3.3 Unkempt grass or weeds

5.3.7 Failure to keep property in a reasonable state of repair:

Penalties and Costs for non-compliance –

\$100.00 first notice

\$150.00 second notice

PLUS THE COST OF the Village hiring a contractor to bring the property into compliance and costs will be attached to property taxes.

- No Owner shall permit a Dog to be Running At Large;
- No Owner shall permit any Dog to trespass on private property, whether on or off a leash.
- The Owner of a Cat shall make every effort to constrain their cat on their own property. (If your cat is an outdoor cat, set a cat litter pan outside, your cat will use this rather than the neighbour's garden).
