2. **DELEGATIONS**: Michelle Wright, RCDC Michelle directed an informal discussion around the growth and development of business as well as residential development within Vilna. She indicated that Council as well as administration act as community navigators by providing information about the community and the available services and advocate for the Village in general.

One of the assets within the Village is the unused portion of the hospital. Current usage is limited to the Medical Clinic and Ambulance Service. Neither of these services pay rent or costs.

Suggested uses for the balance of the facility include"

- Long term care
- Recovery care
- Mental Health and Addiction care
- Mental Health and Addiction counselling
- Grief counselling
- Therapy centre
- Lakeland Destinations
- Tourism Marketing
  - o Uses a Community Investment Grant

Discussions about the possibility of introducing opportunities for new technologies, i.e. changing the way things are done (leading down the path to better our community). Introduce the possibility of small manufacturing centres for these new technologies. Research wind technology, considering off grid opportunities using heat pumps, biomass furnaces, wood chip heating.

Discussion around working with our current assets included

- Brightening up the town by increasing lighting,
- Enticing local professionals to live in the community, including RCMP, teachers, nurses, pharmacists, business management.
- Increased marketing or branding of our municipality as a willing guinea pig for alternative ways to fund infrastructure. We won't be the first "solar village" but, what's next?
- Encourage branches of service and social clubs.
- Encourage more use of the existing facilities.
- Make Vilna a destination for tournaments.
- Better Highway signage
- Greater digital presence, perhaps QR codes, aggressive website and advertising.
- Ways to get out of the "shadow" of larger municipalities, and stand on our own, while continuing to partner and collaborate. We are forever the little duckling, always in debt or just breaking even. Break the cycle of shame, create pride, honor, and gain respect.
- *Historic Vilna, a door into the past, with a window to the future.*
- Revitalize/Create the Vilna Historic Society
- Encourage service businesses, i.e. general stores, card lock, mechanical service, discount retailers.
- Increase Bylaw Enforcement to increase the safety in the community
- Set up security cameras that can help the police in crime enforcement.
- Be prepared to invite people into our community welcome baskets, plaques
- Film production attraction
- More community events

- Boardwalk markets to support the Farmers Markets
- Partnerships in community gardens
- Neighbours engaging with each other
- Potential for growing mushrooms marketing around mushroom branding
- Encourage housing development,
- 3-D technology opportunities

Take advantage of available assets including partnering with neighbouring communities such as Whitefish Reserve, Saddle Lake Reserve and Kikino Settlement.

We have been given the opportunity to work with the organization called Unstoppable Conversations, which has the potential of addressing many of the above items by developing a positive community attitude.

With all of these suggestions and ideas, the Village is ready to <u>Promote Growth</u>. Michelle Wright has given notice that she will be resigning as the Regional Economic Development Coordinator, effective January 31, 2023.

Michelle suggested that this might be a good opportunity to look at RCDC and determine what RCDC should look like going forward.

Mayor Kunyk expressed the feelings of the Council and Community that her presence and hard work will be missed, and wished her the best in future endeavours.

## **PUBLIC WORKS**

• Dale has taken the Water Wastewater Course and is now our licensed Operator, we no longer need to depend on the County License.

### WATER RESERVOIR

• The test results have indicated that we no longer have to do monthly testing, but can reduce the testing to quarterly.

### WATER BREAKS

- On December 18<sup>th</sup>, 2022 a water leak was reported on 49<sup>th</sup> Avenue East. The temperatures were in the low minus 30's and the contractor found that it was too cold to open the street and do the repairs, although they were able to use the vacuum trucks to remove the water. The repairs were completed on December 30<sup>th</sup>.
- On December 20<sup>th</sup>, 2022 a major break occurred on 51<sup>st</sup> Avenue west of 50<sup>th</sup> Street. Because of the cold the repair was not possible to be done immediately. The services were shut off for the properties between 50 Street and 51 Street with the repairs being completed on December 30<sup>th</sup>, 2022.
