  adequacy of services, soil conditions, land use districting, building and development
  conditions, absence or presence of environmental contamination, or the developability of
  the subject land for any intended use by the purchaser.
- no bid will be-accepted where the bidder attempts to attach conditions precedent to the sale of any parcel.
- no terms and conditions of sale will be considered other than those specified by the Village of Vilna.
- no further information is available at the auction regarding the lands to be sold."
- the Terms for payment shall be Cash, bank draft, or certified cheque, E-Transfer or debit. Credit cards will be accepted with a 3% charge. A minimum 25% deposit will be required at the time of sale and the balance within 10 days of the date of public auction. Bidders or their agents must be present at the public auction.
